Charles Brady, PhD, ABPP

Dr. Brady formerly directed the Lindner Center of HOPE's OCD and Anxiety treatment program and was Vice-President of OCD Midwest prior to recently relocating to Washington State and founding a new practice. He is board certified in clinical psychology by the American Board of Professional Psychology. He has served as faculty for the IOCDF's Behavioral Therapy Training Institute program, has made numerous presentations at national conferences and in the media, and has published scholarly articles about the diagnosis and treatment of OCD.
